

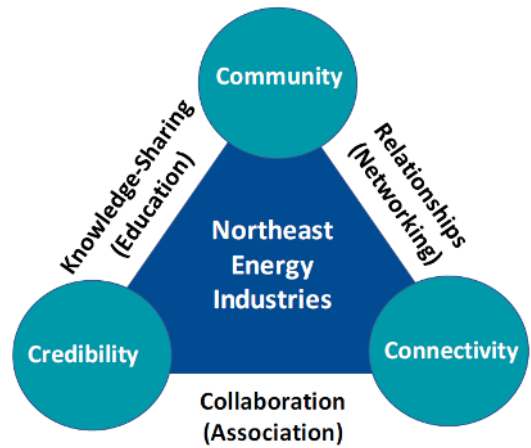

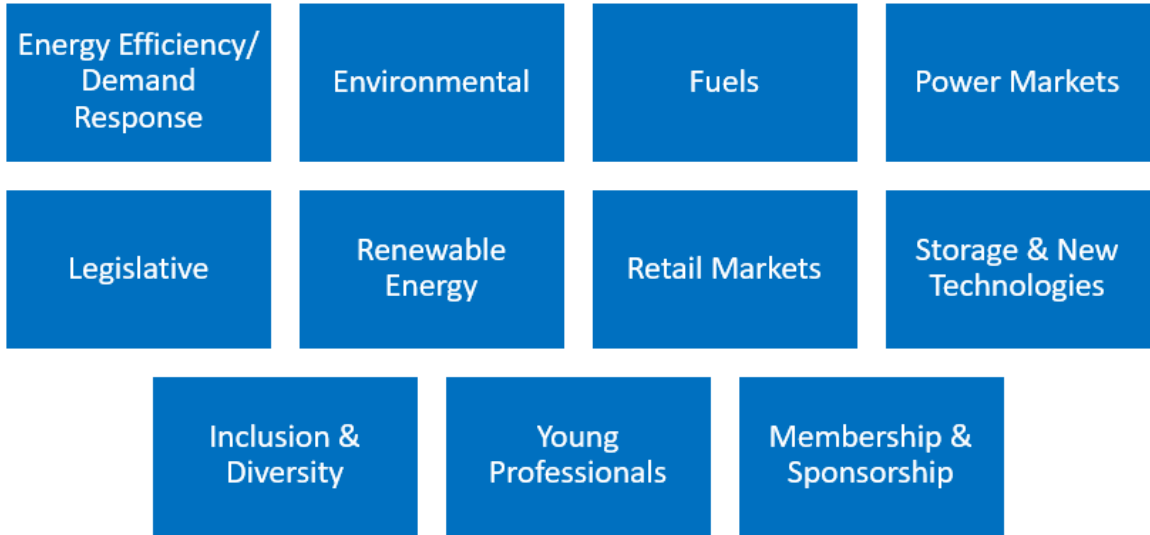
Benefits of Membership
